# **VII. PARLIAMENT SECURITY SERVICE**

# 57. PARLIAMENT SECURITY SERVICE

### 57.1 PARLIAMENT SECURITY SERVICE - AN OVERVIEW

The Parliament Security Service of Rajya Sabha Secretariat looks after the security set up in the Parliament House Complex. Director (Security)/Special Director (Security) of the Rajya Sabha Secretariat exercises security operational control over the Parliament Security Service in the Rajya Sabha Sector under the administrative control of the JS & FA, Rajya Sabha Secretariat. Joint Secretary (Security), Lok Sabha Secretariat is the overall in-charge of security operations of entire Parliament Security including Parliament Security Services of both the Secretariats, Delhi Police, Parliament Duty Group (PDG) and all the other allied security service operating within the Complex. Parliament Security Service being an in - house security service *provides proactive, preventive and protective* security to the VIPs / VVIPs, all the buildings as well the incumbents of Parliament House complex. It is solely responsible for managing the access control and regulation of men, material and vehicles within the said complex.

Being the in-house security service its prime approach revolves around the principles of Access Control based on proper identification, verification, authentication and authorization of men and material resources entering into the Parliament House Complex with the help of modern security gadgets. The threat perception has been increasing over the years due to manifold growth of various terrorist organizations/outfits, refinement in their planning, intelligence, actions and surrogated war-fare tactics employed by organizations sponsoring and nourishing terrorists. New security procedures have been introduced into the security management to counter the ever-changing *modus operandi* of terrorist outfits/ individuals posing severe threat to the Parliament House Complex and its incumbent VIPs.

This avowed objective is achieved in close coordination with various security agencies such as Delhi Police (DP), Parliament Duty Group (PDG), Intelligence Bureau (IB), Special Protection Group (SPG) and National Security Guard (NSG). The Parliament Security Service acts as a key controlling and coordinating agency for providing a foolproof and user friendly security. The Parliament Security Service maintains proper liaison and effective coordination with these security agencies.

One of the important operational activities of the Parliament Security Service is Show Around of the Parliament House Complex to the visitors coming to see the Parliament House during inter-session period. The security officials of Parliament Security Service are deputed to ensure that the visitors, foreign dignitaries and delegations are escorted properly and given factual and significant information about brief history of Parliament and procedures being adopted for conducting the smooth proceedings of the Parliament. However, for the students, it is specially designed more or less on the pattern of an educational excursion. Visitors are also given a brief account about the PH Building, statues and portraits installed in the PH Complex.

# 57.2 UNIFIED OPERATIONAL COMMAND OF PARLIAMENT SECURITY SERVICE

The Joint Secretary (Security), Lok Sabha Secretariat, who operationally heads the Parliament Security Service of both the Lok Sabha / Rajya Sabha Secretariats, in exercise of the powers conferred upon him and with the approval of competent authority of Rajya

Sabha Secretariat, issued an Order No. 1440/UOC/JS(S)/2020 dated 10<sup>th</sup> August, 2020 regarding a single "Unified Operational Command" of the Parliament Security Service wings of Lok Sabha and Rajya Sabha Secretariats. The Order, which came into effect from 7<sup>th</sup> August, 2020, is enumerated below:-

That, there would be a Unified Operational Command of Security Services under Joint Secretary (Security). However, the present system of separate PSS (Lok Sabha & Rajya Sabha) under the supervision of Director level Officer / s may continue, as the service rules of the two Secretariats are different.

(b) All matters related to deployment of officers/staff, leave management and training, in respect of officers/staff of PSS (Rajya Sabha) should be dealt in consultation with the Joint Secretary (Security).

(c) The recommendations of the Joint Secretary (Security) on all security related matters will be uniformly applicable to both the Secretariats. This includes issue of various types of Identity Cards, Entry Passes, Parking Labels/RF Tags, Common dress code of PSS Officials and other operational decisions taken in the interest of Security in PHC. However, in case of any specific need of Rajya Sabha in respect of the points mentioned at 'b' and 'c', decision/directions of Secretary General, Rajya Sabha shall be followed.

(d) Any specific direction of emergent nature issued by and implemented in Lok Sabha will be referred to RSS and implemented subject to approval of Secretary General, Rajya Sabha.

(e) In case of any disagreement between the two Secretariats in matters relating to security, the matter may be referred to Hon'ble Chairman, Rajya Sabha and Hon'ble Speaker, Lok Sabha.

#### 57.3 **RESPONSIBILITIES**

In the aftermath of the terrorist attack on Parliament House on December 13, 2001, the security arrangements were beefed up in accordance with the recommendations of the Joint Parliamentary Committee on Security Matters in Parliament House Complex. All the access points in the Parliament House Complex were streamlined in order to regulate vehicular and pedestrian movement. With the introduction of hi-tech security gadgets at the Access Control Points, the checking of unauthorized entry has been reassessed and made more effective. The Radio Frequency Tag readers have made the identification process more scientific and practical than ever before. It has also assisted in controlling the regular vehicular movements inside the Parliament House Complex. In addition to the above, the other responsibilities of Parliament Security Service are as follows:-

- **a.** Coordination for protection measures for all VVIPs, Members of Parliament, officers and staff of the Rajya Sabha Secretariat and Lok Sabha Secretariat, allied agencies and visitors,
- b. Provide effective and efficient security cover to Parliament House Complex;
- c. Ensuring thorough anti-sabotage and anti-explosive checks of all sectors of Parliament House, Parliament House Annexe/Extension Parliament Library Building.
- **d.** To have a well integrated access control system using all possible technical gadgets for security so as to ensure proper control and regulation of human resources (staff and visitors) and material resources (stores etc.) within Parliament House Complex and to ensure their proper checking, frisking and

regulation. Also to prevent unauthorized entry of men and material inside Parliament House Complex ;

- e. Guarding of the Rajya Sabha Chamber, Galleries, Central Hall and other vital areas of Parliament House, Parliament House Annexe, Annexe Extension and Parliament Library Building against any act of sabotage;
- **f.** Issue of various kind of Passes for Men, Materials and Vehicles to the Parliament House Complex;
- **g.** Issue of Radio Frequency Tags (Vehicles and Men) to Hon'ble MPs, officers and Staff of the Rajya Sabha Secretariat;
- **h.** Verification of antecedents of PA/PS (attached with MPs), Casual labours and visitors before issuing access passes;
- i. To facilitates the Show Around of visitors to the Parliament House;
- j. Maintenance of order within the precincts of Parliament House Complex;
- **k.** Planning and preparation for training of security personnel in coordination with other security and non-security agencies;
- **I.** Fire safety and preventive measures;
- **m.** Performing ceremonial and other duties of Marshal entrusted by the Hon'ble Chairman, Rajya Sabha inside or outside the Parliament House Complex.

#### 57.4 AREA OF FUNCTION

Parliament House Complex *i.e.*, Parliament House, Parliament House Annexe, Parliament House Extension Building and Parliament Library Building is a high security sensitive area. The security arrangements within the Complex are made at a high level and are well coordinated with the police authorities and other security organizations for additional support and assistance. The Parliament Security Service (Rajya Sabha Sect. / Lok Sabha Sect.) being the In-House Security organization, is responsible for maintaining security and order within the Complex in association with various other allied security agencies deployed for the purpose.

In addition to the routine access control and operational security duties in Parliament House Complex, the services of personnel of Parliament Security Service are also requisitioned outside the Parliament House complex during National ceremonies such as Republic Day celebrations at Rajpath, Vijay Chowk, Independence Day celebrations at Red Fort, 'At Home' functions and Swearing in ceremonies at Rashtrapati Bhavan etc. Further, during the National and International Parliamentary Conferences / meetings, the duties of Parliament Security Service increase manifold viz. receiving and seeing-off of National and International delegates at the airport, looking after their lodging, boarding and their security arrangements at the respective hotels and accompanying them to the places of sightseeing apart from performing duties at the venue of such Conferences.

On  $10^{\text{th}}$  Dec. 2020, Hon'ble PM laid the foundation stone of **New Parliament House Building**, wherein 38 officers / officials of PSS / RS were deputed to perform various security / ushering duties, in connection with the said function. Thereafter, an officer of the rank of Joint Director (Security) from PSS / RS has been detailed to facilitate / oversee the Access Control and regulation of Men, Material and Vehicles, for construction work of the said Building.

# 57.5 WINGS UNDER PARLIAMENT SECURITY SERVICE

For effective control and optimum performance, the Parliament Security Service has been divided into various wings, namely Ops-I, Ops-II, IP-PHA & Extn., OP-PHA, Administration, Training and Planning (ATP Wing), Inner Precincts (PH), Deployment & Galleries (PH), PLB and PTI Building, CPIC, Fire & Technical, Sanitation, Marshal and CCS (Central Command Station). **57.6** The Administrative Wing of Parliament Security Service is entrusted with the task of handling the administrative matters pertaining to the officers/ staff of Parliament Security Service such as career progression, livery, space requirement, work allocation, welfare and grievances, *etc*.

Apart from this, various other matters related to security arrangements of the offices of the Rajya Sabha Secretariat, located outside the PH complex viz. North Avenue, official residence of Secretary-General, Rajya Sabha and Plot of the Rajya Sabha Secretariat located at Sector XII, R.K Puram, New Delhi were also looked after by this wing.

## 57.6.1 ADMINISTRATIVE WORK:

- **a.** Updation of records such as manpower status, nominal roll, list of files etc. of Parliament Security Service was accomplished as per the guidelines contained in the manual of the Rajya Sabha Secretariat.
- b. The work related to day to day administrative work and taking up welfare matters such as career progression, Livery, Space requirements and grievances was undertaken by the ATP Wing. Total 151 Applications/Representations of security officials were forwarded to Estt.(G)/G.A. Section / Personnel Section for various reasons i.e. to apply for post outside Parliament like PSC, UPSC, etc. NOC for passport, applications for deputation / invigilators for Exams and permission etc.
- **c.** A total number of **09** RTI Applications were received from the RTI Cell under the RTI Act for which their replies were prepared and forwarded to the RTI Cell for further necessary action at their end.
- **d.** A total number of 02 Office orders regarding work allocation for the officials of the Parliament Security Service, Rajya Sabha Secretariat were circulated. Furthermore, 83 in-house office orders in respect to the substitutes in absence of the officers who proceeded on leave/training were circulated..

# e. 13<sup>TH</sup> December, 2020 Floral Tribute Function

1. A function to pay Floral Tributes to the martyrs, who sacrificed their life during the terrorist attack on Parliament House on the 13<sup>th</sup> December, 2001 was organized on Sunday, the 13<sup>th</sup> of December, 2020 at 1030 hours at the plaque placed between Building Gate Nos. 11 & 12, Parliament House. On this occasion, *Shok Shastra*, 90 Seconds silence was observed followed by floral tributes in the honour of the martyrs.

2. In the wake of Covid-19 Pandemic and as per the guidelines issued by MHA, in order to maintain physical distancing norms *etc.*, some befitting arrangements were made, for this year. Necessary intimation to organize the Floral Tribute Function was sent to the Home Secretary, Govt. of India. Officers /staff of the Secretariat were not invited to ensure social distancing and as a precautionary measure. The strength of the contingent of PDG (CRPF) personnel presenting 'Guard of Honour' to the martyrs was curtailed accordingly.

Family Members of the Martyrs attending the programme were asked to bring negative RT-PCR test report, conducted within 72 hours prior to the function. A letter was also sent to Health Secretary, Govt. of India, with a request to arrange a team of Doctors & paramedics. The said team was stationed at Reception Office, Parliament House to carry out instant COVID detection (Rapid Antigen) test, in case, any family member of martyr / invitee failed to bring negative test report. Also, all the security personnel and other staff, who were deployed in close

proximity to the VVIPs and involved in the floral tribute function at the venue were tested for COVID (RT-PCR) on 11<sup>th</sup> December, 2020 (Friday). Unlike past precedents, the blood donation camp was not organized this year by the Indian Red Cross Society.

3. Sh. M. Vankaiah Naidu, Hon'ble Vice-President of India & Chairman Rajya Sabha; Sh. Narendra Modi, Hon'ble Prime Minister of India; Sh. Om Birla, Hon'ble Speaker, Lok Sabha; Sh. Harivansh, Hon'ble Dy. Chairman, Rajya Sabha; Hon'ble Home Minister; Hon'ble Defence Minister; Leader of the House & Leader of Opposition in Rajya Sabha and some Party leaders attended the programme and paid floral tributes to the Martyrs.

4. Apart from the above, the Secretaries-Generals of both the Secretariats and the Secretary, Rajya Sabha Secretariat, one family member of the Martyr *i.e.*, Sh. Avdesh Kumar (Husband of Martyr Smt. Kamlesh Kumari, Constable, CRPF); Director-General, CRPF and Commissioner of Police, Delhi registered their presence and paid floral tribute to the martyrs.

5. As approved by the Secretary-General, Rajya Sabha, a **Joint Obituary Reference** (on behalf of both Rajya Sabha Secretariat and Lok Sabha Secretariat) to honour our brave Martyrs were published on 13<sup>th</sup> December, 2020 in two (2) major leading Newspapers in Hindi and English languages in Dainik Jagran and Times of India. Necessary financial approval to publish the Obituary was also sought from the competent authority.

6. During the last floral tribute function in the year 2019, it was observed that the inclement weather conditions made it difficult to organize the function smoothly. Therefore, this year, as directed by the Secretary General, it was decided to make an alternative arrangement inside the precincts of the Parliament House Building *i.e.* opposite Room No. 32(Ground Floor), in order to avoid any embarrassing/unpleasant situation. The ATP Wing of the Parliament Security Service, Rajya Sabha Secretariat (PSS/RSS) had arranged for two spare sets of Photographs of Martyrs to meet any contingency. Out of those 2 spare sets, one was placed at the alternative venue inside the Building alongwith other necessary arrangements such as floral decoration and carpeting the area of alighting *i.e.*, from Building Gate No. 9 upto Martyrs' Photograph, opposite Room No. 32.

#### 57.6.2 REPORTS

- **a.** The Monthly reports / Monthly pending work report of the Parliament Security Service were prepared on monthly basis and forwarded to the Secretary-General, Rajya Sabha for his kind perusal during the year 2020.
- **b.** The Annual Report, Performance Profile, Annual Action Plan-2021, Statistical data, Action Plan Review *etc* were forwarded to the concerned section for further necessary action at their end.
- **c.** In the year 2020, the Sectional Manual of Parliament Security Service was updated and after approval from the competent authority was forwarded to O&M Section.
- **d.** The Hindi Quarterly Progress Report of 2020 was sent to the Hindi Rajya Bhasha Prabagh on time

#### 57.6.3 TRAINING AND PLANNING WING

In order to plan specific training programs for Parliament Security Service for the up-gradation of knowledge and professional skills of its personnel and to enhance organizational efficiency, a Training and Planning Wing [T & P Wing] was constituted.

The objective of this wing is to explore and come out with innovative ideas in the field of training, planning, knowledge up-gradation and welfare of the security personnel. The basic thrust is to enhance organizational efficiency by improving professional skills of the security personnel, developing the right attitude in an individual so that his/ her skills can be utilized in the best possible way.

The Training Wing of Parliament Security Service took initiative to liaison with different organizations *i.e.*, National Industrial Security Academy, Hyderabad; Bureau of Police Research and Development; Delhi, National Disaster Management Authority (NDMA), NSG; *etc* and forwarded requests to provide training slots for officers /officials of Parliament Security Service, with a view to upgrade their skills and enhance their knowledge, which would be beneficial in helping them to perform their routine duties.

The Planning Wing of Parliament Security Service has been entrusted with the task of planning and projecting the future needs and requirements pertaining to the up gradation of security in Parliament House, in view of the prevailing security scenario, with an ultimate aim of countering the threats, dangers and coping with future workload through a strategy of planned preparedness.

# 57.7 CENTRAL PASS ISSUE CELL (CPIC)

Centralised Pass Issue Cell [CPIC], Rajya Sabha Secretariat has been entrusted with the task of issuing of Radio Frequency [RF] Tags, Electronic Computerized Passes to Members of Parliament, Ex-MP's, Officers and Staff of Rajya Sabha Secretariat, Officials of Government of India, Media, Allied Agencies, and their vehicles. CPIC, Rajya Sabha Secretriat also issues Bar coded passes with hologram to the Drivers of Lok Sabha and Rajya Sabha M.P.s/Ex.M.Ps. With the help of these RF IDs continuous monitoring of pedestrian and vehicular traffic is accomplished through various types of security gadgets installed at all the access points of PH Complex through Central Command Station (CCS).

In addition to the above, all kinds of bar coded paper passes are also issued by this Wing to PA/PS of Hon'ble MPs /RS and for different Galleries *i.e.* Public Gallery (PG), Distinguished Visitors Gallery (DVG), Press Gallery for Press/Media Personnel, Official Gallery (OG) for officers of various Ministries and Departments and for Central Hall.

#### 57.8 **DEPLOYMENT WING**

This Wing deals with the routine security deployment in the Rajya Sabha Sectors, Parliament House Complex and deployment for special Functions/Events held within and outside PH Complex.

### 57.8.1 ALARM BELL REHEARSAL/Contingency Rehearsal

Contingency Drills (Alarm Bell Rehearsal) comprising of various drills and rescue procedure based on latest incidents, hypothetical situations and threat perception were carried out before the commencement of every Session of the Parliament, which was followed by a comprehensive analysis in de-briefing session by senior officers in GMC Balayogi, Auditorium, PLB.

- Contingency Drill prior to the commencement of 251<sup>th</sup> Session of Rajya Sabha was practiced in the Parliament House Complex on 30.01.2020.
- Contingency Drill prior to the commencement of 252<sup>nd</sup> Session of Rajya Sabha was practiced in the Parliament House Complex on 10.09.2020.
- Rehearsals in connection with, Functions in Central Hall, 13<sup>th</sup> December Martyrs Day New Parliament House Building inauguration programme and

other important events in the Parliament House Complex were also conducted in the year 2020.

# 57.8.2 DEPLOYMENT OF SECURITY STAFF INSIDE PARLIAMENT HOUSE COMPLEX

- Befitting arrangements were made in connection with Oath ceremony function of 45 Members of Parliament, which was held on 22<sup>nd</sup> July, 2020.
- 2. On 20<sup>th</sup> September 2020, during 252<sup>nd</sup> Session of Rajya Sabha, while the discussion on Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020, was going on, some Hon'ble Members from opposition parties trooped into the well of the House and raised slogans against the bill and tried to obstruct the proceedings of the House. On the directions of Special Director (Security), additional Marshals were rushed into the chamber and unruly Members were marshalled out of the Rajya Sabha Chamber, after getting suitable directions from the chair/Secretary-General, Rajya Sabha.

# 57.8.2.1 FUNCTIONS HELD IN CENTRAL HALL, PARLIAMENT HOUSE: -

- a) Total thirty five floral tributes were paid at the portrait of national leaders placed at Central Hall on their birth anniversaries in the year 2020.
- b) Hon'ble President of India addressed Members of both the Houses (Rajya Sabha & Lok Sabha) on first day of Budget session 2020 in Central Hall on 31<sup>st</sup> January, 2020.

# 57.8.2.2 DELEGATIONS VISITED THE PARLIAMENT HOUSE:-

### 57.9 GALLERIES WING

The Galleries Wing of Parliament Security Service looks after the security operations, access control, regulation of visitors and media personnel for the Rajya Sabha Chamber

and other adjoining areas. The areas of First Floor (between Room No.-63 to 73), including committee rooms 63 & 67, Second Floor (between Room No.-92 to 98 & 103 and 104), Third Floor (between Room No.-110 to 124), Rooftop of Central Hall, Rajya Sabha Chamber, Jhanda Floor, Parda Gallery and False Ceiling also comes under the jurisdiction of Galleries Wing.


### 57.11.1 RECEPTION OFFICE - PARLIAMENT HOUSE :



# 57.12 OPERATIONS-II WING (Ops-II)

Operations-II wing is entrusted with the following responsibilities:-

a] Looks after the security of operations of BG 9 & 10, Iron Gate-5, 6, 7 and 7-A, PH to facilitate to and fro movements of VVIPs through the area; b] Regulation of incoming/outgoing stores in PH during the inter-session period from Building Gate-9, PH.

#### 57.12.1 VIP ROUTE

The smooth passage for all the vehicles of VVIP cavalcade permitted through VIP Route was ensured throughout the year. Two trucks carrying General Budget Papers were given entry through VIP Route after meticulous Anti Sabotage Checks. The contingency drill in order to check the security gadgets was carried out on a daily basis during session period, whereas the same was also conducted during inter-session period on the requirement basis prior to the movement of VVIPs. Further, facilitation of Diplomats from various countries and management of their vehicles was also carried out for the President's address during the Budget Session of Parliament during the year 2020.

#### 57.13.1 RECEPTION OFFICE PHA



# 57.14. FIRE AND TECHNICAL WING (F&T)

This wing has been entrusted with the task of looking after the fire prevention measures in the Rajya Sabha Sectors in PH Complex, verification of character/ antecedents of Visitors, Journalists and Casual Labourers. This wing also deals with the cases of loss of Passes, Identity Cards, Parking Labels and organize demonstration of fire fighting equipments in the Parliament House.

#### 57.14.1 FIRE PREVENTIVE MEASURES:

The Fire and Technical Wing conducted monthly routine checking of fire fighting appliances viz. Fire-Hydrants, Fire Extinguishers, Hooters, Sirens, and sensors etc. installed in PH/PHA, RS Sector. An elaborate checking of all the appliances installed in PH

is conducted usually on first Saturday of every month in co-ordination with the staff of Parliament Security Service Lok Sabha, Delhi Fire Service, CPWD and Fire Unit/PH.

#### 57.14.3 FIRE INCIDENT

On 29.07.2019, a fire incident occurred, during the ongoing session, wherein, a delegate Unit of Seat No 10 in the Rajya Sabha Chamber got burnt and smoke started coming out and the house had to be adjourned for a while. A fterwards, Secretary General, Rajya Sabha has desired that the response time in such type of incidents should be instant and Fire officials should respond quickly to control the smoke, in case of fire in Rajya Sabha Chamber .In pursuance of the directions of the senior officers, during the chamber rehearsal, a mock Drill on Fire was conducted in Rajya Sabha Chamber on 29/01/2020.

Thereafter, no fire incidents were reported in the area coming under the jurisdiction of the Rajya Sabha Secretariat, in the year 2020.

#### 57.14.4 ANNUAL FIRE-FIGHTING DRILL

The F&T Wing in collaboration with Delhi Fire Service organized a training programme on fire fighting/safety equipments on 21.12.2020 in Parliament House. During the training programme, lecture on fire including types of fire/fire extinguishers, preventive measures and how to act in case of fire incident was delivered by Delhi Fire Service Officers. Also a practical demonstration of Bronto skylift, fire extinguishers and fire hydrants etc. was also done by Delhi Fire Service Officials. A total number of 83 Security Officials (Parliament Security Service, LS&RS, PDG, Delhi Police, Sanitation Wing, RS and CPWD) attended the said workshop.

## 57.14.5 VERIFICATION OF CHARACTER/ANTECEDENTS

Verifications of character/antecedents of casual Staff, PA/PS attached with Hon'ble MP's, Journalists were carried out through the concerned Police Authority. Instant Verifications of visitors of Public Gallery/ DVG/ Press Gallery were also got conducted from DCP, Special Branch through Fax Machine during Session period. Same procedure of verification was adopted in respect of the Casual Labourers engaged for some tenting/ repair works etc. in PH/ PHA. Apart from the above, **same day** verifications in respect of visitors visiting Public Gallery / Distinguish Visitors Gallery , Casual visitors/Labourers/drivers/Allied agencies etc. were conducted through Special Branch, Delhi Police.

#### 57.15 SANITATION WING

The Sanitation Wing is entrusted with the responsibility of providing clean and hygienic area under the jurisdiction of the Rajya Sabha Secretariat. The purpose of the Sanitation Wing of the Rajya Sabha Secretariat is to maintain a high standard of hygiene and cleanliness by managing timely collection/disposal of waste generated in routine course and to accomplish this goal in a manner that generates high levels of satisfaction. In this context, Sanitation wing was assigned the duties on regular basis in two shifts in Parliament House/PHA/PLB/ Office of the Rajya Sabha at North Avenue, New Delhi

# FUNCTIONAL DUTIES PERFORMED BY THE SANITATION WING

- 1. Cleaning, Washing and Dusting of all Rajya Sabha precincts in PH/ PHA/ PLB/ North Avenue (RSS Sector Complex).
- 2. Cleaning of toilets & Corridors of RSS in PH/PHA/North Avenue Flats (RS Sector Complex).
- 3. Spraying of Finite to counter the mosquito menace.
- 4. Spraying of room freshener.
- 5. Opening & Closing of rooms under the Rajya Sabha Secretariat (Round the clock).
- 6. Opening and closing of Committee room 'A' for meetings as and when required.
- 7. To conduct enquiry regarding theft cases and missing of articles.
- 8. Two Farash were detailed round the clock in shifts in PH/ PHA along with keys of various Building Gates/ Rooms which comes under the jurisdiction of Rajya Sabha Secretariat.

- 9. A joint inspection of Grease Chamber at BG 9 and Chairman's Chamber (Room No. 30/PH) was carried out before the commencement of every session, in collaboration with NDMC (Health Dept.) and other allied agencies of Parliament.
- 10. Before the commencement of every session, Fogging was done in collaboration with NDMC (Health Dept.) to prevent the mosquito breeding in PH Complex, or as and when required.

With effect from *16.03.2020* onwards, the Cleaning/Sanitzation work was carried out by BVG under the supervision of Sanitation Wing, Parliament Security Service, Rajya Sabha Secretariat. To prevent the spread of covid virus, a comprehensive drive to sanitize entire RS Sector in the PHC was done 21<sup>st</sup> & 23<sup>rd</sup> March, 2020 and on 27<sup>th</sup> & 28<sup>th</sup> Sep, 2020

Sanitation Wing did Supervision of Sanitary work done by Bharat Vikas Group(BVG) on daily basis and Sanitization work to contain spread of Covid-19 Virus was regularly done on Monday and Thursday of every week in the area coming under the jurisdiction of the Rajya Sabha Secretariat. Further, sanitization work in the rooms were also conducted where a Corona Positive employee was detected.

During the daily inspection of PTI Building, as and when the short comings were noticed the same were intimated to GA Section and ensured the timely rectification of the same for the smooth functioning of the various Sections of Rajya Sabha Secretariat working from PTI Building. The daily necessary briefing of private security staff deployed at PTI was done on daily basis.

On monthly basis, Inspection of the Rajya Sabha Floors in PTI Building was carried out by the officers [Addl Dir.(S)/PTI/PLB, and SO/PTI] and ensured the necessary arrangements for the safety of man and material in Rajya Sabha Floors in liaison with the concerned officers/sections. The electrical work carried out by CPWD(E)/PHA in Rajya Sabha Floor in PTI Building was also monitored with a view to prevent fire hazard during the year.

#### PARLIAMENT LIBRARY BUILDING

During the year, security arrangements were made at Iron Gate-1 PLB & BPST Gate which was supervised under the directions of Addl Dir.(S)/PTI/PLB and DD/PLB.

A total number of 35 functions / special events/Cabinet/ Committee meetings/ Parliamentary Party meetings were held in PLB during the year 2020.

#### 57.17 WORK DONE IN HINDI

In order to promote working in Hindi language in Parliament Security Service, in the year 2020, all the Wings of PSS were directed to initiate maximum files/notes in Hindi. Besides, they were also directed to forward daily reports bilingually (*i.e. English & Hindi*)

#### 57.18 SPECIAL ARRANGEMENTS DURING COVID-19 PANDEMIC

In the wake of Covid-19 Pandemic and as per the guidelines issued by MHA, in order to maintain physical distancing norms *etc.*, some befitting arrangements were made in the year 2020. The Special Director (Security), issued circulars regarding "Health Advisory in view of Novel Corona virus (COVID-19) outbreak" on  $6^{th}$  March 2020 (English) &  $12^{th}$  March, 2020 (Hindi). On  $17^{th}$  April, 2020, another circular *w.r.t.*, Security arrangements to facilitate officers and staff of RSS, LSS, MoPA and Allied agencies to gain access in Parliament house Complex from 20.04.2020 to 03.05.2020 was published on Rajya Sabha Intranet. During the lock down period, Special Duty roster in accordance to the Direction of MHA regarding Social Distancing/strength/ Guidelines was prepared and circulated.

### Special arrangements:

- 1. In order to contain the spread of Covid 19 in RS Sector, Parliament Security Service ensured to carry out Sanitization of entire Rooms/Area/Corridors/Toilets etc on every Monday and Thursday.
- 2. The chemical namely Sodium Hydrochloride was used in the Sanitization process to prevent the spread of Covid 19 in Rajya Sabha Sector.
- 3. Hand Sanitizers were provided for use of Parliament Security Service Officials of Rajya Sabha Secretariat at various access/duty points of Rajya Sabha Secretariat.
- 4. In case any official of Rajya Sabha Secretariat was found Covid Positive, Parliament Security Service ensured that the room is sealed and further to carry out thorough Sanitization of the concerned areas/Rooms/Sector visited by infected official.
- 5. During the Session, UV Light Sanitizers, received from in DRDO were placed outside Galleries and Lobbies of Rajya Sabha Chamber and Car Tyre Sanitizers at the Iron Gates and Foot Mat Sanitizers at the Building Gates of Parliament House Complex.
- 6. Sanitization of Rajya Sabha Chamber, Adjoining areas was done thrice a day throughout the session period.
- 7. In order to check the temperature of incoming individuals thermal scanners were used at entry points of Parliament House Complex.
- 8. All officials of Parliament Security Service had undergone RT-PCR test 72 hours prior to beginning of the Parliament Session.
- 9. Hon'ble Members were requested to get their COVID tests done in their States or any other place in the country at any authorized lab/test centre within 72 hours prior to attending the Session. All Covid reports of Hon'ble Members, which were received by Special Director(S), were forwarded to the entry gates of Parliament House to avoid inconvenience to the Members while coming to attend the session.
- 10. Due to prevailing COVID-19 situation, and to maintain social distancing norms, seating arrangement of the Members of Rajya Sabha were made in a staggered manner in the Rajya Sabha Chamber, Galleries of the Rajya Sabha (except Press Gallery) and the Lok Sabha Chamber. Accordingly, no visitors were allowed to witness the proceedings of the House during the Session of the Rajya Sabha. Central Hall was also kept reserved, exclusively for the use of sitting Members of Rajya Sabha / Lok Sabha, while the respective House is in Session. Therefore, no Public and Distinguished Visitors' Gallery Passes and Central Hall Passes were issued to the guests of Members.
- 11. It was also decided not to allow PSs/PAs of Hon'ble Members inside the Parliament House during the Session to avoid overcrowding and to obviate the risk of spread of COVID -19 infection.
- 12. In view of the prevailing COVID-19 situation, and in adherence to social distancing norms, Members were requested not to bring any visitors /guests to the Parliament House.

# 57.19 WEEDING OUT

In the wake of Covid-19 Pandemic, the weeding out of the old records was not conducted in the year 2020, however, all the Wings of Parliament Security Service would be requested to prepare list of files, up to the year 2018, which are to be weeded out, as per the guidelines.

# 57.20 BUDGET

• The Parliament Security Service does not have any dedicated Head for budget, however, for Publication of Obituary Reference, Trainings/Field Visit, the Training Unit / Estt. A/c & Budget Section of the Rajya Sabha Secretariat, allocate the funds to do the needful.

# 57.20 ANNUAL OFFICE INSPECTIONS:

• As per the decision of competent authority (O M No. RS.1/1/2020-O&M dated 30<sup>th</sup> December, 2020), to undertake the office inspection once in two years (i.e. biennially), accordingly the inspection process for the years 2019 and 2020 is due in the year 2021.

# 57.21 NEW INITIATIVES:

• Consequent to the approval of competent authority, Special Director(Security) has issued a Circular No. RS/PSS/Spl. Dir(S)/2020-198 dated 25th August 2020, regarding "Unified Operational Command of Parliament Security Service units of Lok Sabha and Rajya Sabha Secretariats" which came into effect from 7th August, 2020.
