The House met at eleven of the clock, MR. CHAIRMAN in the Chair.

FELICITATIONS BY THE CHAIR

MR. CHAIRMAN: Hon. Members, the 95th Academy Award function at Los Angeles was a moment of glory for us. 'The Elephant Whisperers', Ms. Kartiki Gonsalves's debut film, won the Best Documentary Short Film Oscar and the song "*Naatu Naatu*", composed by Shri M.M. Keeravaani with the lyrics by Shri Chandrabose from Shri S.S. Rajamouli's film 'RRR' won the Oscar Best Original Song.

Hon. Members, the wins for 'The Elephant Whisperers' and 'RRR' mark a new recognition of full spectrum of cinema that India produces. This will further the internationalisation of India's film industry. These achievements also reflect global appreciation of vast talent, immense creativity and committed dedication of Indian artists, indeed another facet of our global rise and recognition.

On my own behalf and on behalf of this august House, I congratulate the entire team of artists, everyone associated with this positive venture, 'The Elephant Whisperers' and the movie 'RRR' for the well-earned recognition. Now, the Leader of the House.

SHRI JAIRAM RAMESH (Karnataka): No, Sir. ... (Interruptions)...

SHRI SHAKTISINH GOHIL (Gujarat): No, Sir....(Interruptions)...

MR. CHAIRMAN: I will allow you too.

THE LEADER OF THE HOUSE (SHRI PIYUSH GOYAL): Mr. Chairman, Sir, it is also very interesting ...(Interruptions)..

MR. CHAIRMAN: One second. ...(Interruptions)...

SHRI PIYUSH GOYAL: Only on this point, Sir. ... (Interruptions).. On the award, Sir... (Interruptions)..

MR. CHAIRMAN: One second. ..(Interruptions)...Shaktisinhji, your smile is full of shakti, captivating.

Hon. Members, there are some occasions when we must be only in one mode and that is the mode of happiness and appreciation. It is an occasion where I would plead with the hon. Members, I will give you some time to reflect. Please confine yourselves only to paying our tribute on these great achievements. Do not digress. Now, the Leader of the House. ... (Interruptions)...

SHRI PIYUSH GOYAL: Sir, what I was trying to do, I wanted to share with the House that this 'The Elephant Whisperers' has been made by two women of eminence.

MR. CHAIRMAN: Okay. It is significant.

SHRI PIYUSH GOYAL: It is about gender. It is a respect for our women of India that both ladies associated with 'The Elephant Whisperers' are eminent women, and it is a great mark of recognition for India's women that 'The Elephant Whisperers' has got.(Interruptions)...

One more thing. It is about sustainability, and it also shows that the world today is recognizing that sustainability has become core to our philosophy.(Interruptions)...

And, finally, Sir, 'RRR', the script-writer, is an hon. Member of Parliament, Mr. V.V. Prasad. I think, we all owe a debt of gratitude to acknowledge Mr. V.V. Prasad's contribution. (Interruptions)...

MR. CHAIRMAN: One second.(Interruptions)... Hon. Members, I am so happy that Leader of the House has confined only to the issue. I will now call upon the Leader of the Opposition, and, Khargeji, I am told by the Leader of the House that the script-writer is our Member.(Interruptions)... We need to congratulate him. He is a Member of the House of Elders, the Upper House. Hon. Leader of the Opposition.

SHRI RAJEEV SHUKLA (Chhattisgarh): Sir, is he here?(Interruptions)...

MR. CHAIRMAN: Rajeevji, 'presence' is always impactful. Sometimes, 'absence' is equally impactful. Hon. Leader of the Opposition.

THE LEADER OF THE OPPOSITION (SHRI MALLIKARJUN KHARGE): Sir, I also join to congratulate both the awardees. Particularly, first time, such an award is given to

'Naatu Naatu' and also to 'The Elephant Whisperers.' Both of them come from South India. It is a great pride for us. We are very proud and whatever you have told, we are with you. But my only request is that the Ruling Party should not take credit that 'we have directed it, we have written the poem.' (Interruptions)... 'Modiji has directed this film; they should not say that.' (Interruptions)... That is my only request. (Interruptions)... It is the contribution of the country. (Interruptions)...

SHRI JAIRAM RAMESH: Sir, please don't expunge his remarks.(Interruptions)...

MR. CHAIRMAN: Well, I have had the occasion, hon. Members, this morning to read several newspapers, and there is extensive coverage. It was very enlightening and it is a shift; it is a recognition, we must all take pride. After all, we are proud Indians, take pride (Interruptions)...

SHRI JAIRAM RAMESH: Sir, in 1984, we won an Oscar... (Interruptions)...

SHRI PIYUSH GOYAL: Sir, in 1984, it was not an (Interruptions)...

MR. CHAIRMAN: One second.(Interruptions)... One second.(Interruptions)... Let Mr. Jairam Ramesh speak.(Interruptions)... One second.(Interruptions)... Mr. Jairam Ramesh, confine to this issue and say a few words.(Interruptions)...

SHRI P. BHATTACHARYA (West Bengal): Sir, this is not a subject of debate. Make it very clear. (Interruptions)...

MR. CHAIRMAN: Jairamji, what do you want to say?(Interruptions)... Have you to say anything on this point?(Interruptions)...

SHRI JAIRAM RAMESH: Sir, this is an occasion for collective celebration, not for narrow partisan points scoring like the Leader of the House is doing.(Interruptions)...

MR. CHAIRMAN: You are being unfair. He was not partisan. And the Leader of the Opposition had elevated it to a very high level. We all must enjoy it, relish it. Would any other Member of the House like to reflect before I give the floor to Dr. Amar Patnaik?(Interruptions)...

श्री राजीव शुक्ला : सर, जया बच्चन जी को बोलना है।

MR. CHAIRMAN: Yes, Madam. And mind you, hon. Members, we have one of the greatest artists as Member of the Upper House and a global authority who can reflect on our great achievement. She herself has to her credit inspirational contributions. Madam Jaya Bachchan, on this.

SHRIMATI JAYA BACHCHAN (Uttar Pradesh): Sir, I am so happy and I am so glad that we are discussing the most important ambassadors of this country, the film folks. It does not matter whether they are from the North, East, South or West. They are Indians. I am so happy that while thanking the President, I did mention this point in my speech and I feel vindicated today. I stand here with pride and with dignity for my film fraternity who have represented this country a number of times and have won a number of awards, starting from Shri Satyajit Ray and others. I also want to contribute and say that I know Mr. Rajamouli very well. नीरज जी, आप क्यों बीच-बीच में इतना जोर-जोर से बोलते हैं? ...(व्यवधान)...

MR. CHAIRMAN: Yes, Ma'am.

SHRIMATI JAYA BACHCHAN: The writer is not only the script writer but the story writer as well. He is a Member of this House and it is a great honour. There have been many, many such people from the creative world who have been Nominated to this House, पहले भी और आज भी। ...(व्यवधान)... सर, यह क्रॉनिक डिज़ीज़ होता जा रहा है। ...(व्यवधान)... यह देखिए! ...(व्यवधान)... आवाज़ हमारे पास भी है, हम भी बोल सकते हैं, मगर जब कोई सभ्यता की बात होती है, तो असभ्य व्यवहार मत करिए। ...(व्यवधान)...

श्री सभापति : मैडम, आपकी आवाज़ नहीं है, बुलंद आवाज़ है। You have the distinction of belonging to a family that has a terrific DNA for creativity in the film industry.

SHRIMATI JAYA BACHCHAN: Sir, I thank you for your kind words.

मैं यह कहना चाहती हूँ कि यह शुरुआत है। मैं भारत देश की जनता को धन्यवाद देना चाहती हूँ कि उनकी खातिर विदेश के लोग आज हमारी जनता को रिकोग्नाइज़ कर रहे हैं। The market of cinema is here. It is not in America. Thank you.

MR. CHAIRMAN: Dr. Amar Patnaik.

DR. AMAR PATNAIK (Odisha): Sir, while I join the House in complimenting this tremendous achievement that both the films have achieved, there are a couple of things which come out and which have to be noted. In 'The Elephant Whisperers' the kind of relationship that human beings have with nature, with the animal world, has been depicted very beautifully. I think that is a part of the Indian ethos, Indian culture and that is what we have communicated to the world. I think we must appreciate this particular fact. The second thing is that this movie came from the OTT platform. That basically means that the way we are going ahead, India is going ahead, in digitalization, in using digital platforms in creativity, is something that needs to be commended and noticed as well. As I read in the newspapers, the two characters in that movie still do not know the entire ramification of the fact that they won the Oscar. They have been given a new orphaned elephant to rear up. They have left the two that are already there.

Sir, this is a tremendous achievement and this is a celebration of the fact that we Indians can show to the world the sustainable way of living in this world. As for the song, I think it has caught the imagination of all sections of the society. As Madam Jaya Bachchan*ji* said, this is creativity at its peak, being recognized globally, and I think we must all be very happy about it. We must celebrate it and we must compliment all the people involved and also those who are probably lurking somewhere, whom we must promote, so that we occupy the central place in the comity of nations. Thank you, Sir.

MR. CHAIRMAN: We have another distinguished artist, Dr. Sonal Mansingh.

डा. **सोनल मानसिंह** (**नाम-निर्देशित**) : धन्यवाद, सर। मैं दो बातें कहना चाहती हूँ।

पहली बात, सबके साथ, सबकी आवाज़ों के साथ मेरी भी आवाज़ आज के परफॉर्मिंग जगत से, नृत्य, संगीत के जगत से जा रही है - बहुत अभिनंदन, बहुत बधाई और धन्यवाद के साथ। मुझे इस बात को कहते हुए भी आनन्द है कि जो 'नाटू-नाटू' शब्द है, उसके बारे में यह चर्चा चली कि यह शब्द कहाँ से आया, तो कहते हैं कि यह शब्द 'नट' से आया, नटराज नृत्य से आया और यह नृत्य सबने देखा। अब पूरी दुनिया इस पर नाच रही है, यह हमारे लिए बहुत ही हर्ष की बात है।

सर, दूसरी बात यह है कि 'दि एलिफेंट व्हिस्पर्स' डॉक्यूमेंटरी को भी अवॉर्ड मिला है। मैं कहना चाहती हूँ कि गणेश जी हमारे आराध्य देव हैं, प्रथमेश हैं और हमारे लिए हाथी, हस्ती अत्यंत पूजनीय है, तो एक तरीके से उनको भी आदर दिया गया है, सम्मान दिया गया है। हम सबको इसके बारे में भी बहुत हर्ष होना चाहिए कि हमारे दोनों जो परम पूजनीय नटराज जी और गणेश जी हैं, उनका भी इसमें जिक्र है और इस बात को हम याद रखें। एक बार फिर से बधाई!

MR. CHAIRMAN: Dr. Prashanta Nanda, another hon. Member from the industry.

DR. PRASHANTA NANDA (Odisha): Mr. Chairman, Sir, it is a great moment and a proud moment for our country. I am feeling so happy that I cannot express it. I have spent all my life making films. For sixty years, I have been making films. I have also got national and international awards, but this Oscar Award for a film on OTT platform is beyond my imagination. I hope that all Indians should feel proud. This is our day. Thank you very much.

MR. CHAIRMAN: Hon. Members (Interruptions)...

श्रीमती जया बद्यन: सर, अगर ऑस्कर कभी परफॉर्मेंस की रिकोग्निशन को मिलेगा तो वह पार्लियामेंट के किसी मेम्बर को मिलेगा।...(व्यवधान)...

MR. CHAIRMAN: Hon. Members, I feel the absence of legal giants who perform in Court. I wish they were also here to share our joy today. They are the members of my fraternity and the senior advocates. Now Dr. Santanu Sen; he is elegantly dressed.

DR. SANTANU SEN (West Bengal): Sir, I sincerely congratulate them. Definitely, it is a matter of great pride. It is an honour for the entire country. I sincerely endorse the statement made by our learned Member, Shrimati Jaya Bachchan that it is not the north or west or south or east, it is an achievement of our country at large. Thank you.

DR. JOHN BRITTAS (Kerala): Sir, it is a matter of great pride that we have won the Oscar. Many hon. Members were commenting about the OTT revolution that is happening in this country. It is a platform for national integration. Whenever we go to any place, people talk about Malayalam movies, Tamil movies or Telugu movies. There is another aspect which I would expect the Government to consider. Despite the fact that there is a lot of talk and discussion about the Indian movies, the contribution of media and entertainment industry to the GDP is less than one per cent as compared to other nations where it is more than four per cent. Also, there is a growing concern that a lot of offended people are growing in the country and a lot of censor cuts are happening to the movies. I would ensure that the House should be obviously together to(Interruptions)...

MR. CHAIRMAN: Okay, John Brittas ji; it is a moment of joy. (Interruptions)...

SHRI G.V.L. NARASIMHA RAO (Uttar Pradesh): Thank you, Mr. Chairman, Sir, for the opportunity. It is truly a moment of glory for the Indian cinema. The Director of this movie, Shri Rajamouli, is also a Director of Bahubali movie, which is another international success. Shri V. Vijayendra Prasad, a Nominated Member of this House, is also the story writer for Bahubali, apart from this movie. So, this is not a lone success. Shri V. Vijayendra Prasad, who is not here in the House now, is also a story writer of another successful movie 'Bajrangi Bhaijaan' and several other major hits. 'RRR' is a patriotic film; it is a film against colonialism and it also truly celebrates India's struggle for Independence. Apart from being an Indian, I think, it is a great moment of pride for all Telugus because the original film is Telugu and the song 'Naatu Naatu' is a Telugu song. So, I would like to add that additional moment of glory to this occasion. Thank you, Sir.

श्री राजीव शुक्रा: सर, सबसे पहले मैं आपको धन्यवाद देना चाहता हूं कि आपने एक नई तरह की परम्परा शुरू की है। मुझे लगता है कि इस तरह की उपलब्धियों को सदन में डिस्कस करके उन कलाकारों को बधाई देना एक नया कार्य है और इसकी जितनी सराहना की जाए, उतनी कम है। जैसा कि जया जी ने कहा, मैं इस बात से पूरी तरह सहमत हूं कि भारतीय सिनेमा जगत दक्षिण से लेकर उत्तर तक, जिस तरह से विश्व में बढ़ रहा है, वह दिन दूर नहीं है, जब भारतीय सिनेमा हॉलीवुड को पीछे छोड़ देगा। इसलिए इन सबको बधाई देते हुए मैं इस सदन के माध्यम से यह अपील करना चाहता हूं कि जिस दिन ऑस्कर अवार्ड की ज्यूरी में भारतीय कलाकार और भारतीय लेखक होंगे, उस दिन शायद हमें सबसे ज्यादा प्रसन्नता होगी।

MR. CHAIRMAN: Now, Shri Prakash Javadekar. We will have three more speakers on this point and then come to the Agenda.

SHRI PRAKASH JAVADEKAR (Maharashtra): Mr. Chairman, Sir, the whole House is very happy and the whole country is happy for both the reasons. I will first talk about the documentary, 'The Elephant Whisperers'. This elephant, as Sonal is our deity also. And, more importantly, we have more than 30,000 elephants in our country and we are, probably, the only country which worships trees, animals and nature. So, these are the ethos of our country - living in harmony with nature.

MR. CHAIRMAN: Great. Thank you. Now, Mr. Vaiko.

SHRI VAIKO (Tamil Nadu): Mr. Chairman, Sir, this is the happiest occasion. After a long time, we all join together in complimenting the composer and the singer of RRR

film. But, previously also, Mr. A.R. Rahman got the same award for his composition 'Vande Mataram'

MR. CHAIRMAN: It was 'Jai Ho'.

SHRI VAIKO: Yes, 'Jai Ho'. So, we are proud as this is the second time for music for Tamil Nadu. Therefore, I also wanted to recall what Music Director Mr. A.R. Rahman established and achieved. Thank you, Sir.

श्री सभापति : यदि मैं वकील नहीं बनता, तो कहीं न कहीं एक्टिंग ज़रूर करता। Now, Dr. M. Thambidurai.

श्री मुकुल बालकृष्ण वासनिक (राजस्थान): यदि आप यहां न होते तो हो सकता है कि जो भावनाएं आज हम यहां व्यक्त कर रहे हैं, आपके प्रति भी इसी तरह की भावनाएं हम व्यक्त कर रहे होते।

DR. M. THAMBIDURAI (Tamil Nadu): Mr. Chairman, Sir, I also join all my colleagues in appreciating and congratulating the awardees who got the Oscars. I would like to specially mention that the award-winning documentary 'The Elephant Whisperers' has been produced and shot in Tamil Nadu, in Ooty area. I am very proud of that. There is so much nature that we have in Tamil Nadu. This documentary has shown the Nilgiri Hills. Apart from that, the song from the movie RRR is a good song. We appreciate that and it is a credit given to our country.

I would like to say that the great leaders from our AIADMK Party, MGR and Jayalalithaaji, were also film actors. You know it very well. They are very popular. This movie talks about Dravidian movement. (Interruptions)...

MR. CHAIRMAN: Thank you, hon. Member.

DR. M. THAMBIDURAI (Tamil Nadu): Therefore, we are very thankful for giving us an opportunity to appreciate this achievement. Thank you, Sir.

SHRI SUKHENDU SEKHAR RAY (West Bengal): Sir, thank you for excluding me.

MR. CHAIRMAN: No, Sukhenduji, I can't exclude you. अपना रिश्ता बहुत पुराना और गहरा है। Please take the floor.(Interruptions)... I would request Shri Sukhendu Sekhar Ray to take the floor.

SHRI SUKHENDU SEKHAR RAY: Sorry, Sir, I cannot speak.

MR. CHAIRMAN: Please take the floor.

SHRI SUKHENDU SEKHAR RAY: I cannot speak.

MR. CHAIRMAN: Sukhenduji, we are discussing a very pleasant subject. What happened was that just when I took your name, I had indicated Dr. Sen, your colleague. I thought I must yield in favour of the black as compared to white at the moment. So, I am sure, you will take note of my special request and make your contribution. You come from a State that has a rich culture and has made significant contribution in the field. सुखेन्द्र जी, आप में और हममें नाराज़गी का रिश्ता नहीं हो सकता है।

SHRI SUKHENDU SEKHAR RAY: Sir, I would just like to remind you that as per the normal procedure of the House, firstly, the Leader of the House, then the Leader of the Opposition, then the leaders of the various political parties -- and, as it is a special occasion, then, obviously, the Members of the Parliament who are, by profession, performing artists -- should get the chance to speak. Anyway, it was not maintained. With this rider, I would like to submit before you that whatever has been stated by my hon. colleagues, I share their views, but, through you, I would like to request Shri Bhupender Yadav, the hon. Minister of Environment, Forest and Climate Change for organizing special film shows, particularly of the Elephant Whisperers, for the children, for the school-going boys and girls because day in and day out, the elephants are being killed by speedy trains and poachers. If we organize these shows, it will have a positive thought in the minds of our children. Thank you, Sir.

MR. CHAIRMAN: It is a very constructive suggestion. Shri C.M. Ramesh.

DR. C.M. RAMESH (Andhra Pradesh): Sir, as it mainly concerns the Telugu film industry, kindly allow me to speak in Telugu. * "Sir, the Telugu film industry has won an Oscar Award and is now winning accolades from the entire world. I congratulate music composer, Shri Keeravani, lyricist, Shri Chandrabose, director, Shri Rajamouli, actors, Shri Jr. N. T. Rama Rao & Shri Ram Charan and also the entire team associated with the song. If the House permits, I request your good self to permit this august House to felicitate the entire team after they return to India. Shri V. Vijayendra

Prasad is a Nominated Member of this august House. I thank the hon. Prime Minister for his foresight in recommending such eminent people to the Nominated Members list. Sir, Telugu people are feeling proud and elated with this success. Thank You."

श्रीमती रंजीत रंजन (छत्तीसगढ़): सभापित महोदय, मैं सबसे पहले आपके माध्यम से फिल्म इंडस्ट्री को धन्यवाद देना चाहती हूं, जिसके कारण आज पूरे सदन में मुस्कराहट फैली है, जो बहुत कम देखने को मिलती है। यहां बहुत सारी बातें की गई हैं और मुझे लगता है कि दो बातें अभी कहनी बाकी हैं। 'आरआरआर' और 'दि एलिफेंट व्हिस्परर्स' में दो चीज़ें, मां की ममता और हमारे कल्चर की सिम्प्लिसिटी बहुत अहम थी। उसमें जो डांस था, वह हमारे कल्चर का, हमारी सिम्प्लिसिटी का और मस्त होकर जो इंडिया के लोग डांस करते हैं, उसका प्रतीक है। हमने अपने कल्चर का सम्मान किया, तभी आज अंतरराष्ट्रीय स्तर पर सम्मान हुआ है। मुझे यह लगता है कि हम लोगों के लिए एक बहुत बड़ा लैसन है। सर, जो मां होती है - चाहे मनुष्य का बच्चा हो, जानवर का बच्चा हो या पंछी का हो - मां तो मां होती है और उसका प्यार सबके लिए एक जैसा होता है। हम सबके लिए यह बहुत बड़ा लैसन है। मैं आपके माध्यम से उनको बहुत-बहुत धन्यवाद देती हूं।

श्रीमती प्रियंका चतुर्वेदी (महाराष्ट्र): सर, जैसे हमारे पार्लियामेंटेरियन्स ने बधाई दी, उसी तरह से मैं भी बधाई देना चाहती हूं। मैं एक चीज़ और मेन्शन करना चाहूंगी कि वहां पर एक और इतिहास रचा गया है। वहां पर एक इंडियन एक्ट्रेस दीपिका पादुकोण ने 'नाटू नाटू' गाने को इंट्रोड्यूस किया था, उन्होंने भी ब्लैक ड्रेस पहनी हुई थी, तो मैं उनको भी बधाई देना चाहूंगी। सर, दीपिका पादुकोण से याद आया, मैं एक चीज़ और कहना चाहूंगी कि यह जो बॉयकॉट कल्चर है, अगर ऑस्कर जीतने के बाद सोशल मीडिया प्लैटफॉर्म्स पर बॉयकॉट कल्चर को खत्म करने का काम होगा, तो यह हमारे लिए सौभाग्य की बात होगी। And, Sir, because I am wearing black, I yield the space to Mahua Maji ji, who has been wanting to speak. Thank you so much.

MR. CHAIRMAN: The only culture I know is 'agriculture'.

SHRIMATI PRIYANKA CHATURVEDI: Of course, Sir.

MR. CHAIRMAN: And, let us believe in that. Now, Shri Binoy Viswam.

SHRI BINOY VISWAM (Kerala): Sir, I add my humble voice to the emotionally-packed words of Shrimati Jaya Bachchan. She mentioned the feelings of this House in very beautiful words. This is the moment when we all join together to uphold our culture, its diversity, its richness and its aesthetics. It is no more a narrow one; it is a wide one, and that wideness is to be celebrated now. Sir, the tribes, the

underprivileged and their love for the nature is beautifully shown in the film called 'The Elephant Whisperers'. That film shows how great this country is. In the same way, the dance of 'Naatu Naatu' will always remain in our memory, and I believe that this country will celebrate that dance also. This is the moment that this country thinks about diversity and oneness. Our diversity is the cause of the oneness. It is not that one language is the answer for it. In several languages, North or South, India is one. Telugu or Hindi, India is one. Malayalam or Hindi, India is one. But that idea is not taken seriously by certain quarters.

MR. CHAIRMAN: Thank you.

SHRI BINOY VISWAM: This is the reminder for most of them.

श्री सभापति : सबको 'हाथी मेरे साथी' की याद आ गई है। Now, Dr. Fauzia Khan. Briefly, Madam.

DR. FAUZIA KHAN (Maharashtra): Sir, a great Indian poet has said that if music be the food of joy, sharing makes it paradise. We are spreading the joy of creativity and we are sharing the glory of India here, across ideologies, across regions, across geographical boundaries. So, let's celebrate our diversity; let's celebrate our creativity. It is a proud moment for us. And let's celebrate our gender empowerment.

DR. K. KESHAVA RAO (Telangana): Sir, I don't want to be parochial, but I feel so happy when all of you say such words of praise, because the film is from my State. It is not of my State only; it is a universal film. But you have not taken one name. I am thankful to Dr. Ramesh. It is Keeravani who got the award. His name should be taken. He is the composer. The award is given in the category of 'Original Song'. There are many songs for which the Oscar is given, but there is one category known as 'Original Song', which takes the entire universe into itself. As you might have seen yesterday, all the other joined the dais. I also especially congratulate Mr. Prasad. He is not here. He is not directly associated with it, but he is associated with it in writing along with Mr. Rajamouli. Rajamouli is the writer and his son. Rajamouli and Keeravani along with the actors, whose names Mr Ramesh mentioned, are all from my State. But they are not from my State only; they belong to this country, although they are certainly from the southern region. Thank you very much.

प्रो. मनोज कुमार झा (बिहार): सर, मैं अपने दल और अपने तमाम साथियों की ओर से आपकी और सदन की भावनाओं के साथ अपने आपको एसोसिएट करता हूं। सर, यह सचमुच गर्व का क्षण है, लेकिन गर्व के ऐसे क्षण आने के लिए आवश्यक है - आप जिस राज्य से आए हैं, वहां कई वर्ष रहे - टैगोर साहब कहते थे, 'where the mind is without fear and the head is held high'. आर्ट और कल्चर को बंदिश-मुक्त करना होगा और आजादख्याली को प्रमोट करना होगा, तब हमारे पास ऐसे सैकड़ों ऑस्कर आएंगे। जय हिंद!

श्रीमती सीमा द्विवेदी (उत्तर प्रदेश): सभापित महोदय, मैं बहुत धन्यवाद देना चाहती हूं कि आज आपने सदन को एक साथ करके इतना अच्छा माहौल बनाया है। अभी हमारे सभी सम्मानित सदस्यों ने अपनी तरफ से बधाई दी है और मैं भी सभी के साथ स्वयं को संबद्ध करते हुए बधाई देना चाहती हूं।

महोदय, मैं एक बात कहना चाहती हूं कि क्या पूरब क्या पश्चिम, क्या उत्तर क्या दक्षिण, यह सारा हिंदुस्तान ही अपना है और आज सारा हिंदुस्तान खुश है। महोदय, मैं आज यह कह सकती हूं कि एक 56 इंच के सीने के नाते आज देश के सभी हिंदुस्तानियों का सीना 56 इंच का हो गया है। ...(व्यवधान)... महोदय, मैं बधाई देना चाहती हूं और जिन दो महिलाओं को अवार्ड मिला है, उनके लिए मैं विशेष बधाई देना चाहती हूं।

THE MINISTER OF PARLIAMENTARY AFFAIRS; THE MINISTER OF COAL; AND THE MINISTER OF MINES (SHRI PRALHAD JOSHI): Sir, I also associate with all the Members who have expressed their deep happiness regarding two Oscars at a time for India. It is really a very happy moment for all of us. One of the script writers is Mr. Vijayendra Prasad, who has been Nominated by the hon. President. It is also a very important thing to note how the hon. President is now Nominating Members who are illustrious in their own fields. That is a very important thing. I would like to congratulate him also.(Interruptions)...

SHRI JAIRAM RAMESH: Sir, there have been.... (Interruptions)...

MR. CHAIRMAN: Jairam ji.

SHRI PRALHAD JOSHI: I am only appreciating Shri V. Vijayendra Prasad. (Interruptions)... Why Jairam ji is so agitated, I am not really able to understand. (Interruptions).. Also there is 'The Elephant Whisperers'. Both the producers are women. This shows the Nari Shakti of our country. I congratulate both of them. I also express my happiness and I congratulate them.

SHRI G.K. VASAN (Tamil Nadu): Sir, congratulations to the winners of Oscars. We are proud Indians. I would like to request the Central Government and the State Governments that in hilly terrains where schools are there, 'The Elephant Whisperers' should be screened, so that the students are aware of the nature and the silent intelligence of the elephants which is a must. I request the Central and State Governments to consider this screening for the students in hilly areas.

MR. CHAIRMAN: Hon. Members, before I call three or four Members to contribute significant points to it, I have to inform you that this morning I got good input from very senior people in the film industry and in the field of culture. They said that the Upper House must help develop an ecosystem, so that exploitation of such talent takes place, so that everyone can totally use talent and potential, and wherever there are handicaps, wherever there are hiccups, wherever there are problems, we need to overcome them. I am sure we will have some kind of a discussion during the Session so that we can wholesomely motivate such kind of emergence of an ecosystem.

Shrimati Mahua Maji.

श्रीमती महुआ माजी (झारखंड) : धन्यवाद, माननीय सभापित महोदय। सबसे पहले तो मैं ऑस्कर अवार्ड लाकर हमारे पूरे देश को गौरवान्वित करने वाली पूरी टीम को धन्यवाद देती हूं, उनको हार्दिक बधाई देती हूं। मैं एक अहम मुद्दे की तरफ भी ध्यान आकर्षित करना चाहती हूं कि अभी दोतीन दिन पहले ही साहित्य अकादमी अवार्ड दिया जा रहा था, उसमें 24 स्टेट्स के कलाकार साहित्यकारों में से चुनकर आये हैं, लेकिन उनकी एक समस्या यह है कि उनके लिए सरकार कोई ऐसी पॉलिसी नहीं लाई है ...(व्यवधान)... मैं बताना चाहती हूं कि उनको फ्री मेडिकल की सुविधा होनी चाहिए। महोदय, आज के दिन जिनके कारण हम गौरवान्वित हो रहे हैं, उनकी होल लाइफ के लिए फ्री मेडिकल की सुविधा होनी चाहिए, क्योंकि उनके पास पैसे नहीं होते हैं, वे बहुत ही आर्थिक कमी से जूझ रहे हैं, इसलिए इस तरफ मैं आपका ध्यान दिलाना चाहती हूं, धन्यवाद।

SHRI P. WILSON (Tamil Nadu): Mr. Chairman, Sir, I congratulate the awardees who have won Oscars. I am really happy to say that the film was shot in Ooty which is the Queen of Hills and where elephants are protected. In fact, we have an elephant corridor there. Our Chief Minister, Mr. M.K. Stalin, is taking all the steps to protect the elephants, so that they can freely move and they are not disturbed. The whole of India takes pride in this movie. In 1960s, our then Chief Minister, Dr. Kalaignar, wrote script for *Parasakthi* in Tamil. That film ran for one year and Sivaji Ganesan became popular because of that film. We Indians have talent, and we should be proud that the whole world knows about our talent. Thank you, Mr. Chairman, Sir.

MR. CHAIRMAN: The hon. Minister, Shri Anurag Singh Thakur.

India has the potential to become the content hub of the world. Let us work together to make India the content hub of the world. Nothing is regional today. The Prime Minister says 'local to global'. Our regional has become international. That is a big achievement for India. सर, इसमें बड़ी बात यह है कि 'नाटू नाटू' तेलुगू भाषा में गाया गया था, यह बहुत सारी भाषाओं में डब हुआ, लेकिन मैं कह सकता हूँ कि 30 क्या, आज दुनिया के करोड़ों लोगों के दिलों में 'नाटू नाटू' बज रहा है, तो भारत के संगीत की धुन आज दुनिया भर में बज रही है।

सर, तिमल भाषा में फिल्म बनी - 'दि एलिफेंट व्हिस्परर्स'। यह छोटी बात नहीं है। यह छोटे बजट के साथ बनी, यह एक स्मॉल डाक्युमेंटरी थी, लेकिन आज उसको भी जो मुकाम हासिल हुआ है, उसके लिए मैं अपनी ओर से उन्हें बधाई देता हूँ। चूँकि यह जिम्मेदारी मोदी जी की सरकार में मुझे मिली है, हम कह सकते हैं कि हमने लगातार इसके लिए प्रयास किया। जब टोरोंटो फिल्म फेस्टिवल हुआ, तब राजामौली जी और उनकी पूरी टीम ने उस समय वहाँ पर वर्ल्ड प्रीमियर करने का काम किया, हमने भारतीय फिल्मों को आगे बढ़ाने के लिए मंच दिया। कान फिल्म फेस्टिवल में भी जब भारत और फ्रांस ने अपने डिप्लोमैटिक टाइज़ की 75वीं वर्षगाँठ मनाई, तो जब पहली बार किसी देश को कंट्री ऑफ ऑनर मिला, वह पिछले वर्ष यहाँ भारत को मिला। सर, एक के बाद दूसरा वह क्षेत्र है, जहाँ पर भारत ने फिल्मों के क्षेत्र में अच्छा काम किया है।

श्री सभापति : आप समाप्त कीजिए।

श्री अनुराग सिंह टाकुर: सर, मैं बस दो मिनट में अपनी बात खत्म कर रहा हूँ।

श्री सभापति : एक मिनट।

श्री अनुराग सिंह टाकुर: सर, मैं एक मिनट में अपनी बात खत्म कर दूँगा।

सर, अभी पिछले साल सेंट्रल एशिया का युवाओं का डेलिगेशन आया था। मुझे इस पूरे सदन के सामने यह कहते हुए प्रसन्नता होती है कि जब शाम को भोजन का समय था, तो उन्होंने कहा कि हम कुछ कल्चरल प्रोग्राम करना चाहते हैं। मुझे लगा कि वे अपने देश के गाने बजाएँगे। सर, भारतीय फिल्मों की धुन और उनको गाने का काम उन सेंट्रल एशिया के युवाओं ने किया।

और बात भी कब की! राज कपूर जी की फिल्मों के गाने गाए गए। मिथुन चक्रवर्ती का गाना - 'जिम्मी, जिम्मी, आ जा, आ जा, आ जा', उस पर आज के युवा डांस कर रहे हैं। That is the impact of the film industry. यह मैं इसलिए कह रहा हूँ कि आज 'आरआरआर' ने जो काम किया है, उसके पीछे स्टोरी लिखने वाले, पटकथा लिखने वाले विजयेन्द्र प्रसाद जी इस सदन के सदस्य भी हैं। यह हमारे लिए सबसे बड़े सौभाग्य की बात है कि उन्होंने केवल स्टोरी ही नहीं लिखी, वे एक अच्छे व्यक्ति भी हैं। एक अच्छे व्यक्ति को चुन कर इस सदन का हिस्सा बनने का अवसर दिया गया, उसके लिए भी मैं बहुत आभार प्रकट करता हूँ। हम सबकी ओर से 'आरआरआर' और 'दि एलिफेंट व्हिस्परर्स' के सभी लोगों को बहुत-बहुत बधाई और शुभकामनाएँ!

SHRI ABDUL WAHAB (Kerala): Sir, I congratulate all the artists and even the हाथी मेरा साथी, वह रोज हमारे घर में आता है। Sir, I have a special request to you. Why can't we, MPs, have Naatu Naatu in front of Rashtrapati Bhavan? उन्होंने यूक्रेन के प्रेसिडेंट हाउस के सामने यह किया है, तो हम हमारी द्रौपदी मुर्मू जी के निवास के सामने नाटू नाटू करेंगे। Thank you, Sir.

SHRI RAVICHANDRA VADDIRAJU (Telangana): Sir, I would like to associate myself with this issue of Oscar Awards.

MR. CHAIRMAN: Now, Shri Jaggesh. I am sure that he is from the industry. I had an interaction with him; it was an extremely lively interaction. Please go ahead.

SHRI JAGGESH (Karnataka): Sir, I thank you for giving me an opportunity. I would like to reintroduce myself and my career. I started my cinema career in 1980. I have done about 150 movies in Kannada as a hero. We were very unlucky in those days. When we acted, even the next State could not watch it because there was no internet, media, etc. Only print media was there. Today's generation is very lucky. If you do anything, immediately, it can be watched by many people, even in overseas places. That is the time which has been created in modern India. So, in this period, I would thank our M.P., who is also one of the best writers. We have stepped into Oscar Awards. This is a dream for every cinema artist to get an award in Oscars. I am very grateful because Modi*ji* used to tell one word that all the Indian languages are atma of Bharat. He used to say that like that, we Indians have started taking awards outside. This is the stepping stone of success which we have started now. In future

days, I think, we Indians would rock everywhere, in every field. That is my feeling. I once again congratulate my dear friend. Thank you for giving me time.

श्री मुजीबुल्ला खान (ओडिशा): सर, आज एक कलाकार के नाते मुझे बहुत गर्व महसूस हो रहा है कि हमारा देश दो-दो ऑस्कर जीत कर आया है। मैं सदन के सभी सदस्यों की बात से सहमत हूं और सारे देश को फिर से बधाई देना चाहता हूं, बहुत-बहुत धन्यवाद।

MR. CHAIRMAN: Shri V. Vijayasai Reddy and, then, I would take up the next Agenda.

SHRI V. VIJAYASAI REDDY (Andhra Pradesh): Sir, one issue, which we have conveniently forgotten, is when a cinema or documentary of artistic nature of such a magnitude is produced, it is not because of one person or two persons but it is because of the hard work that has been put in by hundreds of people, be it technicians, artists etc..

MR. CHAIRMAN: Yes.

SHRI V. VIJAYASAI REDDY: Therefore, the appreciation, that is being offered or conferred on this, should go to everyone who has worked for the film or the documentary, as the case may be. Further, irrespective of the language, irrespective of the religion, caste, creed, there are artists everywhere and, therefore, these regional feelings or sub-regional feelings or linguistic feelings should not be there while appreciating this. Thank you very much, Sir.

डा. सुधांशु त्रिवेदी (उत्तर प्रदेश): सर, आज जब कला की इस अभिव्यक्ति के संदर्भ में सुन्दर समन्वय दिखा, तो मेरे मन में एक तथ्य आया और मैंने सोचा कि उसे सदन के पटल पर रख दूं।

जैसा माननीय सदस्या, डा. सोनल मानसिंह जी ने कहा कि 'नाटू' शब्द की उत्पत्ति 'नट' से हुई है और भारतीय संस्कृति में जो सबसे बड़ा ग्रंथ है, वह भरत मुनि का नाट्यशास्त्र ही है, जिसमें नौ रस हैं। एक शांत रस का प्रयोग इसलिए नहीं किया जाता, क्योंकि नाट्य में उसकी अभिव्यक्ति सम्भव नहीं है, इसलिए आठ रस ही प्रयोग किए जाते हैं। यह दक्षिण भारत की दो फिल्मों से गौरव का अवसर है। तिमल संस्कृति में नाट्य के लिए एक तोल्काप्पियम् ग्रंथ है, जो उसी के समकक्ष है। उसमें भी ठीक वैसे ही नौ रस बताए गए हैं एवं उसमें भी शांत रस की ही अभिव्यक्ति नहीं होती है। इसके साथ उसमें भी आठ रस ठीक उसी सीक्वेंस में हैं, जैसे भरत मुनि के नाट्यशास्त्र में हैं। इसलिए मुझे लगता है कि इस 'नाटू' शब्द की शास्त्रीय उत्पत्ति जिस शब्द से है, उसमें दक्षिण से उत्तर का एक सुन्दर समन्वय दिखता है, जो अमृत काल के लिए बहुत सकारात्मक संदेश है।

MR. CHAIRMAN: You made your point.(Interruptions)... You made your point.(Interruptions)...

श्री शक्तिसिंह गोहिल : सर, माइक ...(व्यवधान)... *

MR. CHAIRMAN: Hon. Members, the Leader of the Opposition yesterday raised a point of order. I am seized of the matter. I have indicated that I will give my ruling today. I have had the benefit of interaction with the Leader of the Opposition today. I have also had the benefit of interacting with senior Members of the main opposition party and also the Treasury Benches. In this connection, we are also having a meeting at 2.30 p.m. I have indicated to the hon. Members who interacted with me that this is a very critical issue. We are required to give a final view to this, because this will define what we can debate and what we cannot debate. The issue has been

agitated by the Leader of the Opposition with clarity and it has been pointed out what the Leader of the House has said...

SHRI DIGVIJAYA SINGH (Madhya Pradesh): With clarity.

MR. CHAIRMAN: ...with clarity. The Leader of the House has been very focussed on what he said.(Interruptions)...

SHRI DIGVIJAYA SINGH: Sir, it is repetition.

श्री सभापति: दिग्विजय सिंह जी, वकील की हैसियत से मैंने भी कई बार रेपिटिशन किया है। रेपिटिशन नहीं होना चाहिए, पर सभी ने कभी न कभी रेपिटिशन ज़रूर किया होगा।

MR. CHAIRMAN: Digvijaya Singhji, you can be charged for repeating as Chief Minster for a second term.(Interruptions)... सर, रेपिटिशन तो होता है। Meaning thereby, repetition is healthy for democracy.(Interruptions)... Am I right?(Interruptions)... No; no, repetition(Interruptions)... Digvijaya Singhji is right(Interruptions)...

SHRI SHAKTISINH GOHIL: Our rules do not permit for repetition.(Interruptions)... Our rules say that repetition is not permitted in the House.(Interruptions)... This is what our rules say.(Interruptions)... रूल्स के अंतर्गत रेपिटिशन पर्मिसबल नहीं है।...(व्यवधान)...

MR. CHAIRMAN: Just one second. Hon. Members, Shaktisinh Gohilji has sent a communication to me. Communication of every Member of Parliament is attended by me with expedition. I have gone through his communication. It is very well-worded. We have sought an input from him. And, we have requested him -- he must be getting a communication, if not already got it -- to make it available at the earliest. While the communication was very well premised, the factual part of it was not indicated there. So, we have requested him to give that. He will get a communication to this effect. I am seized of the matter. I can assure you, any issue raised by any Member, in any capacity whatsoever, will engage me with full involvement. And, I will

certainly take a call on it. I have devoted a major part, today and yesterday, in interacting with hon. Members. We will examine the situation -- the constitutional provisions, the rules we have framed, the directives that have been directed by earlier Chairmen, the directives that have been imparted in the Lok Sabha, the situation that is obtaining anywhere in the globe -- and, then, we will take a view. Suppose we hold today that even if the entire House is of one voice, but the rule comes in between for discussion, we will have to deal with that. So, we are meeting the floor leaders today at 2.30 p.m. And, I am sure, you will get my ruling at the earliest, maybe, during the course of the day or tomorrow because this is subject to interaction and being enlightened. I, on my own, cannot have a point of view. I will have a point of view after having collated all other points of view. And, then, I will take a call. I am seized of your matter. You have raised it very carefully, except on one point that you did not provide me the factual premise on which you seek intervention. You think, it is a part of proceedings. I have indicated in my response to you to please spell it out so that I have, before me, a factual matrix and, then, take a call. Now, Mr. Bhupender Yadav.

MR. CHAIRMAN: Bhupender*ji*, please speak on this point only. No transgression from this side or that side. (Interruptions)...

SHRI BHUPENDER YADAV: Sure, Sir.
