BIRTHDAY GREETINGS

MR. CHAIRMAN: Hon. Members, I am pleased to extend warmest birthday greetings to Shrimati Sonia Gandhi, a distinguished Member of this House, on her birthday.

Shrimati Gandhi, who now represents Rajasthan in her first term in this august House since April 2024, has served five consecutive terms in the Lok Sabha from 1999 to 2024. She served as the President of the Indian National Congress from 1998 to 2017 and again from 2019 to 2022 — the longest in the party's history. She happens to be the Chairperson of the United Progressive Alliance from 2004 to 2023.

Shrimati Gandhi has made literary contributions by authoring books "Rajiv" and "Rajiv's World", dedicated to the memory of her late husband, Shri Rajiv Gandhi, who served as the Prime Minister of this country and later on the Leader of the Opposition in the Lok Sabha. I personally cherish the meaningful bond I shared with late Shri Rajiv Gandhi.

Shrimati Gandhi has been involved with preserving our national heritage which is evident in her editorial work on "Freedom's Daughter" and "Two Alone, Two Together" — compilations of correspondence between India's first Prime Minister Pandit Nehru and Shrimati Indira Gandhi, who became Prime Minister later on. She has a Diploma in Conservation of Oil Paintings from the National Museum, New Delhi, reflecting her keen interest in art, music, and handicrafts.

Presently, Shrimati Gandhi's son, Shri Rahul Gandhi, serves as the Leader of the Opposition in the Lok Sabha, and her daughter, Shrimati Priyanka Gandhi Vadra, has been recently elected to the Lok Sabha.

On behalf of this House and personally, I extend heartfelt wishes to Shrimati Sonia Gandhi *ji* for a long, healthy, and prosperous life ahead and extend greetings to her family, friends, and admirers.

This House, the Rajya Sabha, derives its strength and purpose from the very principles enshrined in the Indian Constitution. It is our duty and constitutional ordainment, as Members of Parliament, to uphold and protect these principles, ensuring that the aspirations of those who came before us continue to resonate in the policies and practices of today.

Let us take inspiration from the vision and dedication that the Members of the Constituent Assembly exemplified. Their debates remind us of the value of constructive dialogue, mutual respect and harmony in the House, which are essential for the functioning of parliamentary democracy.

Hon. Members, as we recall the import and significance of this momentous and seminal situation in our history, let us also renew our pledge and commitment to serve the people of India with integrity and diligence, ever mindful of the sacrifices that made our democratic journey possible.

SHRI TIRUCHI SIVA: Sir, it is a point of order. Kindly let me lend your ears. ...(Interruptions)... It is concerned to all Members, from this side and that side.

MR. CHAIRMAN: Under which rule?

SHRI TIRUCHI SIVA: You want the rule!

MR. CHAIRMAN: A point of order has to be raised under a rule.

SHRI TIRUCHI SIVA: Sir, it is under Rule 258. It says, "Any Member may at any point of time submit a point of order for the decision of the Chairman, but in doing so, shall confine himself to stating the point". Sir, I am confining to my point.

MR. CHAIRMAN: One minute. You are a very senior Member. ...(Interruptions)... Rule 258 does say that every Member has a right to raise a point of order. ...(Interruptions)... But, he has to raise a point of order with respect to another rule.

SOME HON. MEMBERS: Sir, ... (Interruptions)...

MR. CHAIRMAN: Hon. Members, I need to inform ...(Interruptions)... One minute. ...(Interruptions)... Sanjayji, take your seat. ...(Interruptions)... Hon. Members, I had, in my Chamber, a meeting with the Leader of the House and the Leader of the Opposition. The purpose of that meeting was to ensure that the House runs smoothly. ...(Interruptions)... Both sides, including some other floor leaders who are present here, like Shri Tiruchi Siva, Shri Pramod Tiwari and Shri Jairam Ramesh, had a frank discussion and they signaled two things; one, that integrity and sovereignty of the nation is sacred for us. We cannot allow any forces within the country or outside to sacrilege our unity, our integrity and our sovereignty...(Interruptions)... The leaders had a frank discussion. They have agreed to meet in my Chamber tomorrow at 10.30 a.m.

OBSERVATION BY THE CHAIR

MR. CHAIRMAN: I would appeal to all the Members of the House to carefully consider the oath of the Constitution they have taken. Their oath is very specific. ...(Interruptions)... They have to ensure integrity of the nation on a priority basis. Any challenge to the unity of the nation, to the integrity of the nation, from within or outside, requires all of us to offer united challenge. This is not a challenge to one section or the other. ...(Interruptions)... This is a challenge to our very existence. We, as a nation, are committed to fight these sinister forces, these forces which are

inimical to India. This inimical force mechanism, a deep state that is evolving, is required to be neutralized by all of us. ... (Interruptions)...

I would appeal to the hon. Members to share the sentiments of the people at large. ... (Interruptions)... People at large are extremely concerned. ... (Interruptions)... All divisive forces, all forces that are pernicious to the concept of Bharat, all forces that have sinister design to run down our democracy, to bring down our progress, to impede our economic upsurge, have to be defeated by us. ... (Interruptions)... That is the sentiment which 1.4 billion people share. That sentiment has to emanate from this House also. ... (Interruptions)... This House, at this critical moment, when the country is facing such serious challenges, must send a united voice to motivate the people at large, inspire the people, so that these forces are defeated. ... (Interruptions)... We, in this country, that is rising at a very fast pace, cannot afford to either countenance or overlook such kind of evil designs. ... (Interruptions)... And our conduct should be such that people get more interest in our Parliament. ... (Interruptions)... If dialogue in Parliament does not share the sentiments of the people at large, the Parliament will get into irrelevance. ... (Interruptions)... It is fundamental for Parliament to debate such serious challenges that the nation is facing from forces that are determined to run down our country by employing various mechanisms. ... (Interruptions)... The functioning of deep state has been noticed. ... (Interruptions)... It affects us more perniciously than COVID. ... (Interruptions)... This is an occasion where the entire nation needs to speak in one voice. ... (Interruptions)... The nation must give a direction to the people at large, so that all enemies of Bharat, within or outside, are taught a lesson never to venture in a misadventure to challenge our integrity, our sovereignty, and impede our progress. ... (Interruptions)... I am sure the Members from both sides will soul-search themselves, live up to their oath, and set an example to the nation that we are first Indians and the nation is first for us. ... (Interruptions)... Our commitment to nationalism has to be 100 per cent. ... (Interruptions)... We shall not allow our nationalism to go down. ... (Interruptions)... We will not bear any challenge to our unity, integrity, and sovereignty. ... (Interruptions)... I am sure the meeting that I had with the Leader of the House, the Leader of the Opposition and senior floor leaders will be continued tomorrow at 10.30 a.m. in my Chamber. ...(Interruptions)... The House stands adjourned to meet at 11 a.m. on Tuesday, the 10th December 2024.
