#### **SUMMONS**

Summons for the Two Hundred and Second Session of the Rajya Sabha was issued to the Members on the  $18^{\rm th}$  June, 2004.

#### **DURATION OF THE SESSION**

The Two Hundred and Second Session of the Rajya Sabha commenced on the 5<sup>th</sup> July, 2004. The House adjourned for three weeks on the 23<sup>rd</sup> July, 2004 to enable the Department-related Parliamentary Standing Committees to examine and report on the Demands for Grants of various Ministries/Departments and reassembled on the 16<sup>th</sup> August, 2004. The House was scheduled to terminate on the 3<sup>rd</sup> September, 2004, but due to continuous interruptions on certain issues, the House was adjourned sine die on the 26<sup>th</sup> August, 2004. The House sat for 24 days and the actual hours of sittings were 67 hours and 15 minutes (excluding recess intervals). The House was prorogued by the President on the 30<sup>th</sup> August, 2004.
